

Aireen Grace Andal is a graduate student in political philosophy and a researcher at the Center for Comparative Studies on Toleration and Recognition at the Ural Federal University. She is a citizen of the Philippines, where she obtained a degree in sociology and credits in demography at the University of the Philippines. She has engaged in demographic and sociological empirical research in the fields of rural development, community-based participatory action research, and gender studies in the Global South. Her recent research interests are in the fields of urban spaces, international relations, ethics, and biopolitics.

Anastasia Beliaeva graduated from the Department of Philosophy at Moscow State University and received her PhD in philosophy in 2008. In 2017 she received a master's degree in social anthropology. She is currently Associate Professor of Philosophy at the Pirogov Russian National Research Medical University in Moscow. Presently, she is working in the fields of medical anthropology and social history of Soviet and post-Soviet medicine. Her interests include changing constructions of illness, the body, and medical knowledge in post-Soviet Russia. The research project she is now working on focuses on vegetovascular dystonia as a Soviet culturally constructed illness. Her most recent publication documents the history of this illness in Soviet medicine ("The Case of Vegetovascular Dystonia: Inventing the Most Common Soviet Disease," forthcoming in 2019 in *Canadian Slavonic Papers*).

Zhanna Chernova is Professor in the Department of Sociology, National Research University—Higher School of Economics, Saint Petersburg. Her research interests are related to the study of family policy in Russia and Europe. She is currently involved in a number of projects on the well-being of children left without parental care, foster parenthood, and the life trajectories of orphanage graduates in Russia. She is the author of scores of articles and books about family policy, gender relations, and family practices.

Meri Kulmala received her PhD in sociology from the University of Helsinki, Finland. She currently works as a university researcher and research coordinator at the Helsinki Inequality Initiative (INEQ), a multidisciplinary platform that brings together academics from different departments of the University of Helsinki studying the causes and consequences of intersecting inequalities. For more than a decade Kulmala worked at the University of Helsinki's Aleksanteri Institute on issues relating to Russia and social welfare. She is currently leading an international interdisciplinary research project on child welfare reform in Russia and is involved in a University of Helsinki project exploring youth well-being in the Arctic region. She has published internationally on Russian social policy and NGOs.

She is the author of several articles on parenthood, family, social inequality, and education.

Ilya Utekhin received his PhD in 2000 from the Russian Academy of Sciences, Institute of Anthropology and Ethnology (Moscow). He is Professor and Head of the Department of Anthropology at the European University at St. Petersburg. He studies communicative interaction and, particularly, human-computer interaction. He is the author of a classic study of the everyday life in Soviet and post-Soviet communal apartments *Essays on the Communal Living* (in Russian; OGI, 2001) and A Virtual Museum of Soviet Everyday Life.
